Grading: The grade for this course is based on (i) class attendance and participation and (ii) completion of assignments. The possible grades are S and U. To get a grade of S you should do 80% of the assignments and attend and participate in at least eight of the ten course meetings. The course meetings are to be held at 1:30 pm on Wednesdays during the fall semester in PHSC 1105. Tentative dates for the Wednesday class meetings are Aug. 24, Aug. 31, Sept. 7, Sept. 14, Sept. 21, Sept. 28, Oct. 12, Oct. 19, Oct. 26, and Nov. 9.

(There are no tests in this course, but if there were, I would include information here about my policy on make-up exams. I usually write something like this: “If you are unable to attend a test because of illness, please call me BEFORE the test begins. If I am not in my office, leave a message for me at the Mathematics Department; the number is 325-6711. I will arrange a make-up exam. Other potential reasons for make-up exams include absences related to other university coursework. These should be discussed with me in advance. In general, make-ups will not be given for quizzes, and late homework will not be accepted.”
